1. ACCEPTANCE OF TERMS

3. REFUND POLICY

The email must come from your current email on our system and include your full name, mobile number, email and reason for the refund request. You must receive email confirmation from us as proof that your email was received by us in a timely manner. read carefully all t&c, privacy policy and payment agreements before your enrollment. Conditions apply **

4. PURCHASES

When confirming a payment or transaction with UCCASH Tourism, you agree and hold full responsibility for paying the full amount for that transaction. A part of the payment or transaction may include taxes, shipping costs, or other similar fees. Although some of the products and services on the UCCASH Tourism website are provided by third-parties, UCCASH Tourism will work with you in order to make sure you are happy with the products and services provided on the website. However, as it may be difficult or impossible to determine the nature and complexity of transactions in general prior to your request for a refund, full or partial refunds and the amount of each refund will be at the sole discretion of UCCASH Tourism. 5. PAYMENT INSTRUMENTS

When you disclose a Payment Instrument to UCCASH Tourism in relation to a financial transaction, you are representing and warranting to UCCASH Tourism that you have the necessary rights required to use the Payment Instrument to pay for the financial transaction in full. UCCASH Tourism reserves the right to store information related to the Payment Instrument associated with a financial transaction. UCCASH Tourism will charge one or more Payment Instruments disclosed by you for the full amount of a financial transaction before you are provided access to the products and/or services related to the financial transaction.



If the Payment Instrument is a credit card or debit card, UCCASH Tourism reserves the right to pre-authorize the financial transaction for the full amount. Once the financial transaction is complete, the full amount will be charged to the Payment Instrument

6. ACTIONS AND TERMS

You agree to authorize UCCASH Tourism, using third parties directly or indirectly, to make any inquiries that UCCASH Tourism considers necessary at UCCASH Tourism's discretion pertaining to your identity and creditworthiness. You also agree to submit to any payment verification protocols that are requested by UCCASH Tourism in order to verify your payment. UCCASH Tourism may terminate your transaction if UCCASH Tourism believes that the transaction violates the terms of this Agreement or UCCASH Tourism believes that the transaction may result in financial loss. UCCASH Tourism may place a delay on a payment for a period of time, limit payment sources for a transaction, and limit your ability to make a payment or deactivate your account if UCCASH Tourism believes doing so may prevent financial loss. UCCASH Tourism may contact your payment source issuer, law enforcement, or impacted third parties and share details of any transactions you have participated in if UCCASH Tourism believes doing so may prevent financial loss or a violation of law.

UCCASH Tourism reserves, at its sole discretion or as otherwise required by law, the right to contact law enforcement agencies in situations where UCCASH Tourism cannot verify your identity or creditworthiness related to a financial transaction and believes a crime or misdemeanor may be taking place. UCCASH Tourism, at its sole discretion, may cancel any financial transaction it believes is in violation of any of its Terms and Conditions, Privacy Policy, this Agreement or any other agreement associated with a financial transaction.

UCCASH Tourism further reserves the right, at its sole discretion, to take any necessary steps to collect past due amounts from you, including expenses associated with collections, attorneys' fees and interest. Interest will accrue on any past due amounts at the rate of the lesser of 1% per month or the lawful maximum.

7. DISPUTES

If you believe that an unauthorized, illegal, or otherwise problematic transaction has occurred under your account, you agree to notify UCCASH Tourism immediately. To the fullest extent permitted by law, you waive all claims against UCCASH Tourism related to payments unless you submit the claim to UCCASH Tourism within 30 days after the charge. You are responsible for and agree to reimburse UCCASH Tourism for all fees, fines, penalties, costs and other liabilities incurred by UCCASH Tourism that were caused or arose out of payments that you authorized. If you enter into a transaction with a third party and have a dispute over the goods or services you purchased, UCCASH Tourism has no liability for such goods or services.

UCCASH Tourism may provide notices to you by sending you a message through UCCASH Tourism's website, products and/or services, or by sending them to an email address you previously provided to UCCASH Tourism. These notices shall be considered received by you within twenty-four (24) hours of the time posted.

You must send notices to us relating to financial transactions by contacting us at uccashtourism.com/support. The Payment Agreement in place at the time you confirm a financial transaction will govern that financial transaction. No remedies exist to you for the failure of UCCASH Tourism to allow for you to complete a financial transaction at any given time.
